  up discussion regarding fixing some other areas of the building such as the janitor's
  closet, North door, and other minor repairs.
- Landscaping There was discussion regarding the landscaping around the building and how it needs some attention. April suggested getting rid of everything in the landscaping area and planting some grass so it would be less maintenance. Joe was going to get with Suzette and Brandon to see if there has been any more discussion/ideas regarding the landscaping.
- Piano Repair Miranda discussed the two pianos located in the other end of the building. They are out of tune, can't move them without scratching the floor, etc. Miranda would like to try and grow the music program within 4-H and be able to utilize those in other ways. Miranda was going to look into finding someone who might be able to help fix the pianos.
- New Officers Cindy Griffin discussed how everyone should be thinking about potential new officers to discuss at the next meeting because that will be voted on in September.

#### Other:

 EMA – Chris Springer and Roberta Yerk were present from the EMA to introduce themselves, discuss what they are able to offer and some changes that have been made in their department. The main focus of their agency is related to Homeland Security. The goal for year 2020 is for EMA to connect with the Ag. Association/ Fair to discuss goals for events and how they can help.

- Antique Power Association There was some conversation from Joe regarding
  what the process if for someone wanting to rent the building in the antique tractor area.
  It was discussed having someone reach out to Don Wright to see if there were any
  events going on before renting the building out to someone.
- **Grounds Director** Chad discussed the possibility of having a paid, full-time position that would be maintenance for the building as well as the fairgrounds.
